



Release of National Connections Academy

Summer School and Full-Time Student Transcript Policy

National Connections Academy **summer school students** are entitled to one free official Summer School transcript sent to a third party such as a high school or post-secondary institution. Unofficial transcripts can be printed by the student at any time while they are enrolled in the course, and for approximately two weeks after they have completed the course. Additional official transcripts will be sent upon request for a fee.

National Connections Academy **full-time students** may also print unofficial transcripts at any time while enrolled. Full-time students may request to have transcripts sent to third parties such as to institutions of higher education, military institutions, and prospective employers, free of charge. There is no limit on the number of official transcripts full-time students may request.

Official transcripts will be released *only with prior written approval* from the student's parent(s)/legal guardian(s), or from the student if he or she is aged 18 or older or an emancipated minor. National Connections Academy requires advance notice of at least **10 working days for all official transcript requests**. Requests should be made using the attached Transcript Request Form.
